If you are a debtor and have court-ordered child support or alimony payments, even if those payments are current, you must complete a Domestic Support Obligation form before the Trustee will conclude your meeting. - 5. If you are a debtor and you do not have an attorney, a completed, signed and dated copy of the Declaration for Debtors Without An Attorney.
