### **TO ALL INTERESTED PARTIES:**

**PLEASE NOTE** that the 11 U.S.C. § 341(a) meeting of creditors (the “Meeting of Creditors”) will take place via ZOOM ONLY at **08:00am on October 29, 2024**. The notice of the meeting of creditors that you received has the ZOOM instructions. They are as follows:

1. GO TO ZOOM.US/JOIN
2. ENTER MEETING ID: 9873459194
3. ENTER PASSCODE: 5564413706
  - a. **If having issues logging into ZOOM- please call 1-213-592-3540**
    - i. **Once you have dialed in, please enter passcode: 5564413706 then press #**

**PLEASE FURTHER NOTE** that in the event you do not have the ability to use a computer, lap-top or cell phone to be able to get into or log-in to ZOOM, you can still call in [AUDIO ZOOM] to participate in the meeting of creditors. If you are having issues with log-in to ZOOM, you can call 213-452-0071 or email at [gonzaleztrustee@att.net](mailto:gonzaleztrustee@att.net). You can also use the ZOOM private chat feature to communicate with the Trustee and/or the Trustee’s administrator. You should log-in to ZOOM at least 10 minutes before the start of the scheduled hour of your Meeting of Creditors.

### **PROCEDURES DURING THE MEETING OF CREDITORS:**

1. You do not need to check-in; simply make sure that you are in the ZOOM meeting or waiting room [to be allowed access];
  2. Each meeting will be recorded by the Trustee. There will be multiple parties on the ZOOM/call and any background noise may disrupt the recording for one or more meetings;
  3. Once connected to the ZOOM/conference line, you must place your computer/phone on mute until your case is called by the Trustee;
  4. Each attorney making an appearance at the Meeting of Creditor, must state so at the commencement of the meeting on the particular case. If an attorney is appearing as special counsel or appearance attorney for another attorney, the attorney must make that clarification on the record;
  5. When the case is called, must make sure to un-mute yourself and allow the video button so that the Trustee can see the person appearing on the record. Each person must speak loudly and clearly into the computer microphone/telephone so that responses, statements and questions are audible on the recording. Please try to eliminate any background noise before your case is called;
  6. If you are a debtor, you must have already read the bankruptcy information pamphlet/sheet. A copy of the bankruptcy information pamphlet is found at: <https://www.justice.gov/ust/bankruptcy-information-sheet> ; they are available in multiple languages; **ENGLISH & SPANISH VERSION**

7. If you are a debtor and have court-ordered child support or alimony payments, even if those payments are current, you must complete a Domestic Support Obligation form before the Trustee will conclude your meeting. If you need a copy of the Domestic Support Obligation form, please send an email to [gonzaleztrustee@att.net](mailto:gonzaleztrustee@att.net) before the Meeting of Creditors. **THE DOMESTIC SUPPORT OBLIGATION FORM IS ON THE WEBSITE.**

8. The Trustee will announce the order of the calendar at the beginning of each hour so that the parties are aware of the calendar number they are appearing on; and,
9. When your matter is completed, please immediately hang up and/or disconnect via ZOOM by pressing the “LEAVE” button. Once the calendar has been completed by the Trustee, the Trustee will ask if any matters need to be recalled and you will be given an opportunity to have the Meeting of Creditors recalled. Do not interrupt the Trustee to ask about your Meeting of Creditors.

**DOCUMENTS REQUIRED TEN (10) DAYS BEFORE THE MEETING OF CREDITORS:**

1. Documents shall be submitted to the Trustee through the Axos Document Delivery website. If you are unable to submit documents through the Axos Document Delivery website, documents may be emailed to [gonzaleztrustee@att.net](mailto:gonzaleztrustee@att.net);
2. The following documents must be electronically sent to the Trustee by the debtor or the debtor’s counsel at least 7 days prior to the Meeting of Creditors:
3. A copy of the most recently filed state and federal tax returns;
4. A copy of a valid, government issued picture identification card (i.e., state issued driver’s license, identification card or a passport).
5. A copy of a social security card, Medicare card, W2 or 1099 wage statement bearing the debtor’s entire social security number, employer identification number or tax identification number;
6. If you are a debtor and need an interpreter, you or your attorney will need to make the request in writing to [gonzaleztrustee@att.net](mailto:gonzaleztrustee@att.net) for an interpreter [and specifying the language needed]; there is no charge for the usage of an interpreter. **A FORM FOR A TRANSLATOR IS ON THE WEBSITE**

7. If you are a debtor and you do not have an attorney, a completed, signed and dated copy of the “Declaration for Debtors Without An Attorney.” A copy of the “Declaration for Debtors Without An Attorney” is found at: [https://www.justice.gov/ust-regions-r16/file/notice\\_declaration\\_without\\_an\\_att\\_eng\\_1.pdf/download](https://www.justice.gov/ust-regions-r16/file/notice_declaration_without_an_att_eng_1.pdf/download).
